

IN 2013, WALL STREET WARFIGHTER FOUNDATION (WSWF) TRAINED 17 SERVICE DIABLED VETERANS IN THE RESIDENT PROGRAM IN PHILADELPHIA. 12 HAVE ACCEPTED FULL-TIME POSITIONS; 3 ARE IN INTERSHIPS OR INTERVIEWING FOR POSITIONS; 2 RETURNED TO COLLEGE FOR ADVANCED DEGREES. THE WSWF PROGRAM IS A SIX MONTH IN-RESIDENCE COURSE WHICH INCLUDES CLASSWORK, FIELD WORK, CERTIFICATION EXAM PREPARATION AND TESTING, MENTORSHIPS AND APPRENTICESHIP/INTERNSHIPS, ALL DESIGNED TO HELP THESE VETERANS' GAIN ACCESS TO REWARDING CAREERS. WSWF ALSO SUPPORTS VETERANS THROUGH A NON-RESIDENT, SELF-PACED PROGRAM. IN 2013, 47 VETERANS BEGAN THEIR STUDIES FROM THEIR HOMES/CURRENT LOCATIONS. 21 HAVE ACCEPTED FULL-TIME POSITIONS; 23 ARE CONTINUING THE STUDY PORTION IN PREPARATION FOR CERTIFICATION; 3 WITHDREW FROM THE PROGRAM.
